Abstract

The South Dakota State University Foundation is an independent nonprofit organization dedicated to the advancement of South Dakota State University. The collection is composed of financial statements, newsletters, fundraising promotional material, and other publications produced by the South Dakota State University Foundation.

Historical Note

The South Dakota State University Foundation is an independent 501(c)(3) nonprofit organization dedicated to the advancement of South Dakota State University. The Foundation was created in 1946, largely inspired by the need to provide funding for an invention by Professor E.L. Erickson. The mission of the SDSU Foundation is: "Uniting the dreams of our students, university and donors to build a better SDSU." The Foundation raises and administers scholarship funds that benefit more than 4,500 students, and spearheads private fundraising campaigns for multimillion-dollar capital projects, including the state-of-the-art Avera Health and Science Center. The Foundation is guided by a 95-member Council of Trustees.

Contents Note

The collection is composed of financial statements, newsletters, fundraising promotional material, and other publications produced by the South Dakota State University Foundation.

The financial statements are reports of accountants and certified public accountants, and schedules of investments made by the foundation. These reports include auditor's reports.

The bulk of this series consists of items published by the SDSU Foundation, such as the Honor Roll of Contributors which lists benefactor to the Foundation. Also included is material related to specific fundraising events, such as for the Pride of the Dakota's marching band, Solberg Hall, the Coughlin Campanile, and the Performing Arts Center.

An item of note is writing by Keith Jensen, a former member of the Foundation Board of Directors which gives a history of development at South Dakota State University.
